WHEREAS, the Sheriff has the statutory authority to enforce the Revised Code throughout Portage County; and

WHEREAS, the Portage County Solid Waste Management District desires services in order to enforce the unauthorized or improper disposal of solid waste under Ohio law; now therefore be it

RESOLVED, the Board of District Commissioners for the Portage County Solid Waste Management District agrees to enter into an agreement for services for the year 2018 with the Portage County Sheriff's Department in an amount not to exceed \$82,932.00 for the purpose of providing environmental protection services for the time period January 1, 2018 through December 31, 2018; and be it further
