RESOLUTION NO. 21-165

RE: AUTHORIZING THE AGREEMENT BETWEEN THE PORTAGE COUNTY SOLID WASTE MANAGEMENT DISTRICT AND THE ATWATER TOWNSHIP TRUSTEES TO PROVIDE RECYCLING COLLECTION SERVICES.

It was moved by Anthony J. Badalamenti, seconded by Vicki A. Kline that the following resolution be adopted:

WHEREAS, the Portage County Solid Waste Management District Board of Commissioners currently provides curbside recycling collection services to several Portage County Political Subdivisions; and

WHEREAS, the District Board of Commissioners and the Atwater Township Trustees wish to enter into an agreement for the purpose of collection of residential recyclables; now therefore be it

RESOLVED, that the Portage County Solid Waste Management District Board of Commissioners agrees to enter into an agreement effective January 1, 2022 through July 1, 2023. This agreement will automatically renew for an additional twelve (12) month term (i.e., from July 1st through the following June 30th) subject to the terms and conditions of the agreement; now therefore be it

RESOLVED, that the Portage County Solid Waste Management District Board of Commissioners and the Atwater Township Trustees agrees upon the rate of \$5.50 per month for bi-weekly services as outlined in Section 9.1 Unit Prices Bid of the agreement; now therefore be it


